Consequences

- 1. **First Course of Action:** Should any student display inappropriate, disruptive behavior:
 - The teacher will speak privately with the student to:
 - a) Restate classroom rules and expectations
 - b) Understand and appreciate the student's perspective
 - The teacher will notify the parent and the Educational Director regarding the conversation
 - The Educational Director will review the events with the teacher
- 2. **Second Course of Action:** Should inappropriate, disruptive behavior continue:
 - A meeting with the parent and child will take place to:
 - a) Restate the class rules and expectations
 - b) Review the behavior that required such a meeting
 - c) Create a shared plan for the future
 - d) Outline any future consequences should the behavior continue
- **3. Third Course of Action:** If inappropriate, disruptive behavior continues:
 - The student will be sent to the office and the parent will be contacted
 - The Educational Director will speak with the student, parent and teacher to make suggestions to encourage respectful behavior and restate the consequences
- **4. Fourth Course of Action:** If inappropriate, disruptive behavior continues still:
 - The student will be sent to the office and the parent will be called and asked to pick up the student
 - The student will remain in the office until the parent arrives
 - Any missed class work will need to be completed at home and brought in the next class
- **5. Final Course of Action:** As a final resort, if all previous efforts prove ineffective, the school reserves the right to ask the child to leave the school.
